It gives low viscosity pastes at low shear rates with dilatant flow, good air release and good ageing properties, also with isocyanates. PEVIKON[™] P1412 gives products with low water absorption, good weather-ability, high transparency and high gloss.
- Applications PEVIKONTM P1412 is recommended for coil coating, base and top coat in technical coating, top coat flooring, sealants, dipping, rotational and slush moulding. Due to its low sieve residue, low water absorption and good weather-ability PEVIKONTM P1412 performs excellent in outdoor applications like coil panels, tarpaulins, roofing, buoys and fenders. The resin is food compliant and is therefore also suitable for cap closures and lids.
